# **DESCRIPTION**

EnviroStrip™ is a non-flammable, water-based stripper for clear and/or pigmented acrylic sealers. It is also designed to help remove deeply embedded greasy soil on concrete floors and surfaces. It has a pleasant fresh citrus smell and performs effective stripping without the use of flammable solvents and harsh chemicals.

# **APPLICATION**

### **Acrylic Sealer Removal**

EnviroStrip™ may be sprayed from a pump-up sprayer, brushed, or poured on and squeegeed evenly across the surface to be treated. Apply at the rate of approximately 1-gallon to150 sq. ft. Allow Enviro-Strip™ to stand for a minimum of 20 minutes and rinse thoroughly with water.

Heavy sealer removal may require heavier application rates and/or agitation with nylon bristle broom or power scrubber. Test in a small area before applying Enviro-Strip across the complete area.

### NOTE:

- EnviroStrip™ is most effective when evaporation is managed. For best results, cover treated area with plastic sheeting to help minimize evaporation.
- Once acrylic softens scrap or pressure wash residue into a collection area. Collect residue and follow below listed disposal.

### **Grease Residue Removal**

EnviroStrip™ may be sprayed from a pump-up sprayer, brushed, or poured on and squeegeed evenly across the surface to be treated. After applying, agitate the surface with a colorfast nylon bristle broom. For interior work utilize either wet vacuum or mop until the rinse water is clear and clean. To remove stubborn stains, you may need to apply twice and scrub with a broom or brush.

### NOTE:

 EnviroStrip™ is most effective when evaporation is managed. For best results, cover treated area with plastic sheeting to help minimize evaporation.

# **CLEAN-UP**

Before  $EnviroStrip^{TM}$  dries; spills and tools can be cleaned up with water.

# **DISPOSAL**
